## Proof needed to claim EITC, CTC/ACTC/ODC, AOTC and/or HOH filing status:

- Proof of relationship (child's birth certificate)
- Proof of residence (a letter from the child's doctor/school on letterhead) must include:
  - o the child's name,
  - o the child's date of birth,
  - o the child's address (for the year shown on your letter),
  - the dates the child lived at the same address as you (must be more than half of the tax year),
  - o the name of the child's custodial parent,
  - o the doctor's or a school administrator's name,
  - o the doctor's or a school administrator's signature, and
  - o the doctor's or a school administrator's phone number.
